FOOD VENDOR INFORMATION

All food booths at Art in the Park are fundraisers for local non-profit organizations. It is the responsibility of each food vendor to choose a non-profit organization to partner with, and to arrange to share a portion of the profits from this event.

Electrical supply in the food vendor area is limited and can be unreliable if overloaded, so we need to limit the number of vendors to those that can be adequately served by the available supply. There is only a limited number of pedestals with 50 amps, so if that's what you will require, we need to know ahead of time, before making the space assignments. All food vendors needing electricity must have generators. Also, as a result of the way the pedestals are arranged, it is not possible to have all vendors set up on the pavement, the way we used to do. Nor is it possible to have all vendors set up on the grass. **Last year we had a problem with overcrowding - too many vendors on the grass, blocking off access to and visibility of vendors on the pavement. This year, you will be assigned a space either on the grass or on the pavement, and you will be required to stick to the plan. Also, to avoid overcrowding, we will be limiting the number of vendors allowed to 10, and we will strive, within those limits, to provide the best possible balance of menu items.**

Veteran's Park regulations forbid the use of stakes for setting up booths, so you must provide . weights for . tents and . canopies.

All food vendors must have a Food Vendor Event Permit, available from the Cochise County Health Department, either from their website or at their location in the Foothills Blvd. Cochise County complex.

Setup must be done by noon on Friday, October 3rd, so that the County Health Inspector can do his job. Serving food to accommodate vendors on Friday is optional, but you must be prepared to serve food for all of both of the event days, starting at 9am on Saturday, Oct. 4th. Event hours are: 9am - 5pm on Saturday, and 9am - 4 pm on Sunday. If you run out of food and close your booth space early, your application for next year will be flagged for review.
